New location: 1310' FSL & 1310' FEL, Sec 5-T17S-R31E

The above move is required to comply with the New Mexico Oil Conservation Division Rule which requires all well locations be a minimum of 10' from all quarter-quarter section lines. Because this move is only 10' from quarter-quarter section lines, the surface utilized for the Drilling Pad and Reserve Pit will remain unchanged. All excavation work will remain within the confines approved in the original APD.

A drilling rig is currently working in this area. As per telephone conversation with the BLM's Shannon Shaw, this move has been tentatively approved.

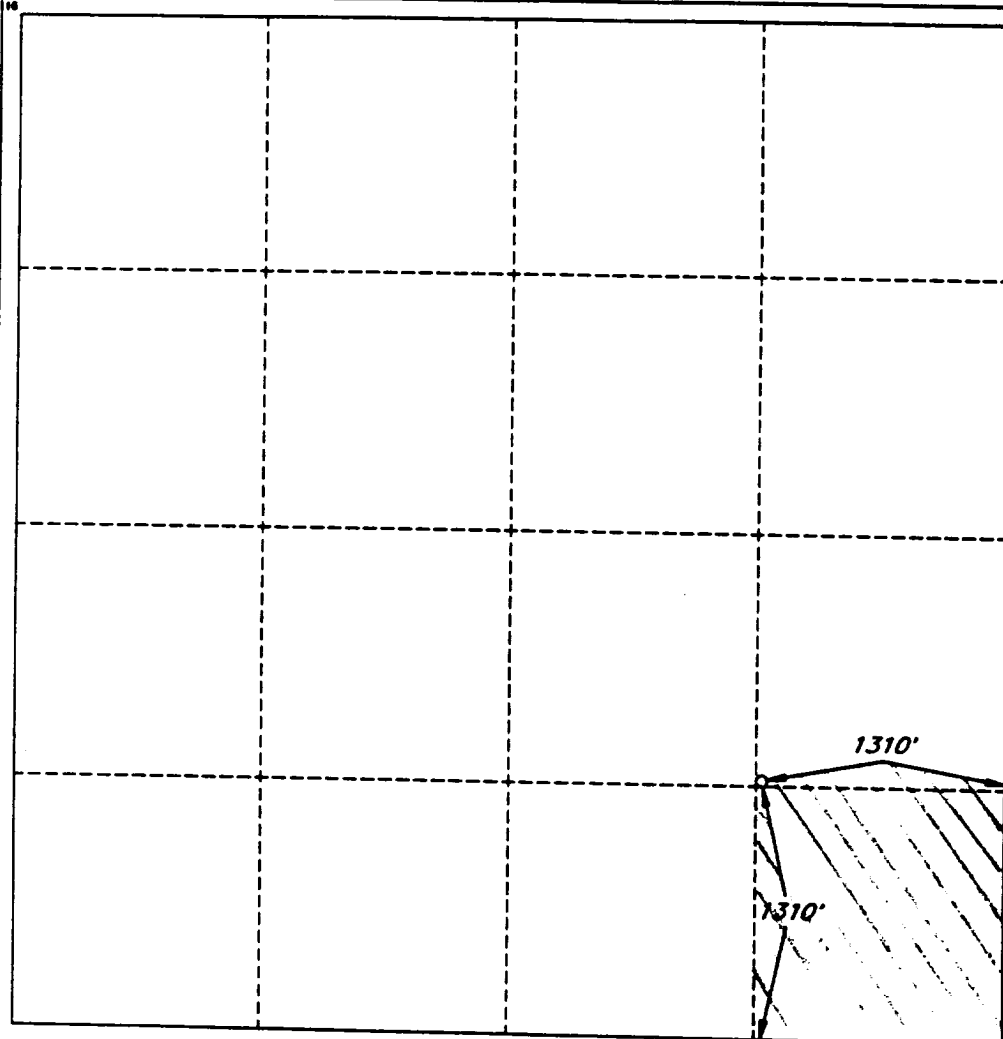

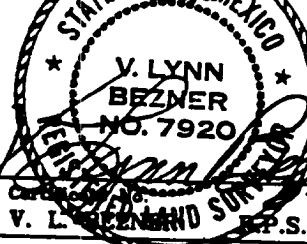
