On 11/17/94, we perf'd 3693'-3857' (22 - .40" holes). On 11/19/94, we acidized 3807'-3857' w/1575 gals 15% HCl acid. On 11/19/94, we acidized perfs 3693'-3726' w/1078 gals 15% HCl acid. On 11/21/94, we frac'd 3693'-3857' w/53,000 gals YF120 gel + 3650 gals WF120 flush + 126,000# 20/40 brady sand + 24,000# resin coated sand.

On 12/07/94, we perf'd 3241'-3616'. We acidized these perfs w/2000 gals 15% HCl acid. On 12/10/94, we frac'd 3241'-3616' w/22,000 gals Viking I-30 gel + 58,000# 20/40 brady sand + 20,000# 20/40 resin coated sand.

On 12/22/94, we perf'd 2873'-3113'. We acidized these perfs w/2000 gals 15% HCl acid. On 12/27/94, we frac'd 2873'-3113 w/42,000 gals 30# x-linked gal + 94,000# 20/40 brady sand + 29,000# resin coated sand.
