Cemented csg as follows: Lead w/180 sx 35/65 POZ "C" + 6% gel + 2% CaCl₂ + 1/4 lb/sk celloflake; wt 12.7 ppg, yield 1.86 cft/sk. Tailed in w/200 sx Class "C" + 2% CaCl₂, wt 14.8 ppg, yield 1.32 cft/sk. Circ'd cmt to surface.

Reached TD of 4215' on 12/12/95.
