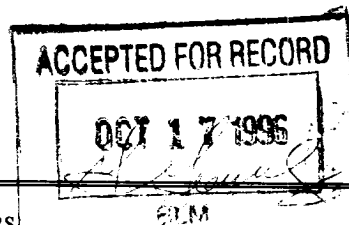

Acidized Grayburg perfs 3082'-3143' w/500 gals 15% HCl acid.
Ran 5 1/2" AD-1 NP & PC pkr and set @ 3053'. Ran 2 3/8" IPC tbg. Tested, OK.
