Workover Existing Water Injection Well As Follows:

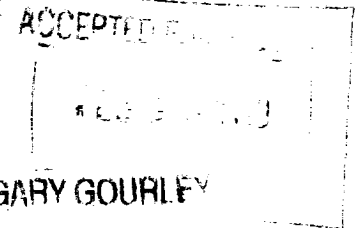
2/10/99 – Run bit and scraper to 3570'. Circulate wellbore clean.

2/11/99 – Set CIBP @ 3550'.

Acidize perforations 3202'-3405' w/1500 gals 15% HCl acid + 2500# rock salt.

Acidize perforations 2806'-3075' w/1500 gals 15% HCl acid + 3000# rock salt.

2/12/99 – RIH with packer, SN and tubing. Set packer @ 2719'. Return well to injection.
