Cemented csg as follows: Lead - 150 sx 35/65 POZ "C" + 6% gel + 2% CaCl₂ + 1/4 lb/sk celloflake, (wt 12.7 ppg, yield 1.86 cft/sk). Tail - 200 sx Class "C" + 2% CaCl₂, (wt 14.8 ppg, yield 1.32 cft/sk). Circ'd cmt to surface.

Reached TD of 3735' on 6/19/96.

Ran production csg as follows: 88 jts, 5 1/2", 15.50#, J-55, LT&C, Float shoe @ 3734', float collar @ 3687'. Top - 78 jts, 3319.61'; middle 1 jt, 39.20'; bottom 9 jts, 389.29'.
