Cemented csg as follows: Lead - 300 sx 35/65 POZ "C" + 6% gel + 2% CaCl₂ + 1/4 lb/sk celloseal, (wt 12.7 ppg, yield 1.86 cft/sk). Tail - 200 sx Class "C" + 2% CaCl₂, (wt 14.8 ppg, yield 1.32 cft/sk). **Circ'd cmt to surface.**

Reached TD of 3830' on 4/14/96.

Ran 5 1/2" prod csg as follows: 90 jts, 5 1/2", 15.50#, J-55, LT&C. Csg shoe @ 3829', float collar @ 3781'. Top - 80 jts, 3432.41'; middle - 1 jt, 12'; bottom 9 jts, 395.19'.

Cemented csg as follows: Lead - 800 sx 35/65 "C" + 4% gel + 5% salt + 1/4 lb/sk celloflake, (wt 13 ppg, yield 1.76 cft/sk). Tail - 350 sx Class "H" + 10% Thixad + 1/4 lb/sk celloflake, (wt 14.5 ppg, yield 1.52 cft/sk). **Circ'd cmt to surface.**
