MIRU Norton Drilling Co., Rig #5. Spudded 12-1/4" surface hole @ 11:00 a.m., 08/31/96. Drilled hole to 440'. Ran 10 jts. 8-5/8", 23#, K-55, LT& C csg. Set at 436'. Halliburton cemented with 325 sx. Class "C" containing 1/4#/sk. Flocele + 2% CaCl. Plug down @ 5:30 a.m., 09/01/96. Circulated 66 sx. cmt. BLM was notified, no representative present. NU BOP & tested csg. to 1000# for 30 minutes, no pressure loss. WOC 12 hrs.

Drilled 7-7/8" production hole to a depth of 4000'. Ran logs and elected to run casing. Ran 95 jts. 5-1/2" 17#, J-55, LT&C csg. Set at 4000'. Halliburton cemented w/1000 sx. Halliburton Lite + 8# salt/sk. + 1/4# Flocele/sk. followed by 250 sx. Premium Plus w/3#KCL/sk. + .5% Halad 344 + 1/4# Flocele/sk. Displaced w/1 bbl. FW + 12 bbls. MSA + 80 bbls. FW. Plug down at 10:00 a.m. 09/05/96. Circ. 96 sx. cmt. Pressure tested casing to 1500# for 30 minutes, no pressure loss. Released rig at 12:00 a.m. 09/05/96. BLM was notified, no representative present.

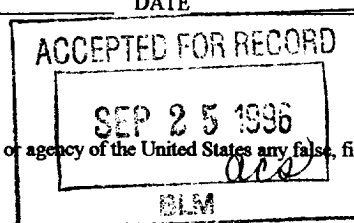
