Class "C" containing 1/4#/sk. Flocele + 2% CaCl. Plug down @ 10:15 p.m., 01/08/97. Circulated 85 sx. cmt. BLM was notified, no representative present. NU BOP & tested csg. to 1000# for 30 minutes, no pressure loss. WOC 18 hrs.

Drilled 7-7/8" production hole to a depth of 3950'. Ran casing as follows: Ran 97 jts. 5-1/2" 17#, J-55, LT&C csg. Set at 3950'. Halliburton cemented w/800 sks. Halliburton Lite + 8# salt/sk. + 1/4# Flocele/sk. followed by 250 sks. Premium Plus w/3#KCL/sk. + .5% Halad 344 + 1/4# Flocele/sk. Displaced w/91 bbls. FW w/Lo-Surf 300. Plug down at 9:45 a.m. 01/14/97. Circ. 107 sks. cmt. No acid spotted. Pressure tested casing to 1500# for 30 minutes, no pressure loss. Released rig at 11:45 a.m. 01/14/97. BLM was notified, no representative present.
