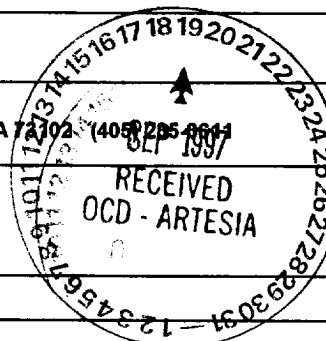

Ran surface casing as follows: 11 jts 8 5/8" 24# J-55 8rd ST&C, set @ 465'.

Cemented casing as follows: Lead - 175 sxs 35/65 POZ "C" w/6% gel, 2% CaCl2 & 1/4 lb/sk celloflake, (wt 12.7 ppg, yield 1.87 cft/sk). Tail - 200 sxs "C" w/2% CaCl2, (wt 14.8 ppg, yield 1.32 cft/sk). Circ'd cement to surface.

Reached TD of 3792'.

Ran production casing as follows: 83 jts 5 1/2" 15.5# J-55 8rd LT&C, set @ 3791', float collar @ 3744'.

Cemented casing as follows: Lead - 1100 sxs 35/65 "C" POZ w/4% gel, 5% salt & 1/4 lb/sk celloflake, (wt 13.01 ppg, yield 1.75 cft/sk). Tail - 275 sxs Class "H" w/10% A10-B, 5% salt & 1/4 lb/sk celloflake, (wt 14.5 ppg, yield 1.57 cft/sk). Circ'd cement to surface.
