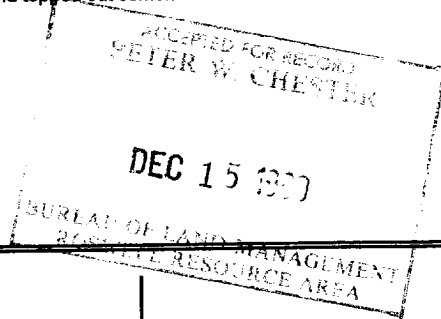
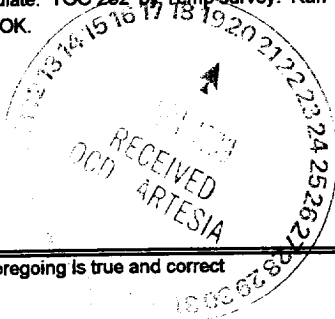

Weight 11.6#/gal, 2.73 cu ft/sk, 170 bbls. 2nd Slurry - 180 sx Class C with 2% CaCl<sub>2</sub>; weight 14.8#/gal, 1.34 cu ft/sk 43 bbls. Cement did not circulate. TOC 282' by Lamp survey. Ran 1" PVC and topped out cement with 400 sx Class C cement. WOC 10 hrs - test casing to 600# - OK.
