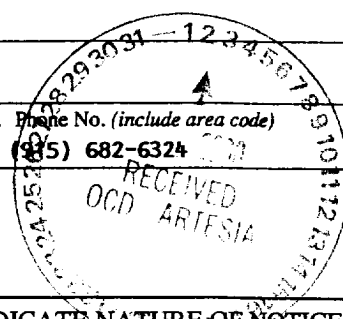

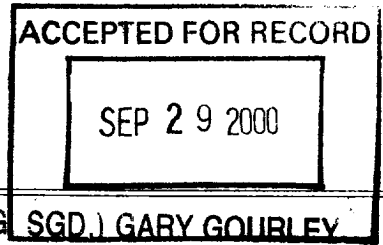

- 9/14/00 Run open hole logs. (High RLA Micro-CFL/GR, 3 DLDCN/GR, EL. Capture/GR log)
- 9/15/00 Run 105 jts 5 1/1" 17# casing to 4550'. Set DV tool at 2742'. Cement 1st stage with 420 sxs "PVL" with 4 pps Kolite + 1 pps SoCl YD-1.42 DENS-13.0. Circulate 50sxs cement through DV tool. Cement 2nd stage with 1350 sxs 35:65 POZ C + 6% gel + 2% CaCl YD-1.99 DENS-12.6; Tail with 150 sxs Class C neat. Circulate 80 sxs to reserve pit. NDBOP's and cut off 5 1/2 casing and clean pits.
- 9/16/00 Drilling rig released, waiting on completion.
