- 8.) Start pumping load water.

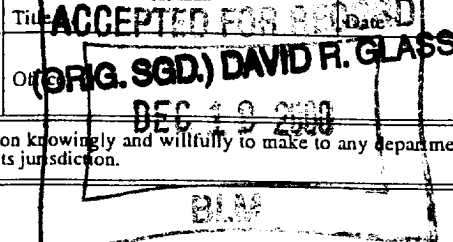
