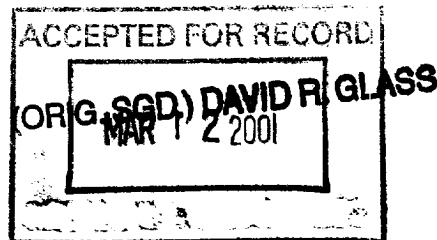

1/4# sx CF. Tail w/150 sx Class C Neat. Circulate 40 sx to reserve pit.
NDBOP. Cut off 5 1/2" casing & clean pits.
