BJ pumped 150 sks Class "H" cement w/10% thixotropic w/1% CaCl & 1/4#/sk cello flake w/10#/sk LCM then 325 sks Class "C" cement w/2% CaCl. Drop plug on fly, displace w/20 BFW, bump plug-held. Cement did not circulate to surface. WOC 5 hours, put 9 yds rat hole cement around backside of 8 5/8" casing to bring to surface. Gene Hunt & Don Early of BLM on location for cementing and cement to surface respectively. WOC 18 hrs(per NMOCD requirement.)
