Pulled rods and tubing. Cleaned out to 1741' GR. Dumped 500 gallons diesel down casing followed by 250 gallons 15% regular acid. Ran 5-1/2" tension packer on 2-3/8" tubing coated internally with plastic. Loaded annulus with inhibited water and set packer at 1608.51' GR. Started water injection 2-3-70. Well accepting 258 barrels water per day at 0 psi.
