Acidized new perforations with 3000 gallons 15% HCL NE acid and rubber ball sealers. Maximum treating pressure 1900 psi. Sand pumped to T. D. of 1806' C. M.

The *Agrobacterium* strains were grown in the YEA medium for 24 h at 28 °C. The cell concentration of the strains was adjusted to 1.0 × 10⁸ cells/ml. The cell suspension was mixed with the plant tissue and the transformation efficiency was determined. The results were expressed as the mean ± SD of three independent experiments. The asterisks indicate the significant difference between the strains at the same concentration of the cell suspension.
