ADDITIONAL INFORMATION (If recompletion give full details of proposed plan of work.)

Will run approx. 200' of 13 3/8" casing at surface to shut off surface water, pull when run 8 5/8". We intend to drill well to top of grayberg sand at approx. 950'. Will core grayberg sand. If grayberg sand is not productive will continue to drill to the San Andres. Set 8 5/8" pipe and cement & circulate to top. Pipe to be set through all artesian aquifer formations. Then run 5 1/2" oil string, cement and circulate to surface. 50' into 8 5/8" casing
