Pulled rods and tubing, cleaned out to 1,753'. Dumped 500 gallons Diesel down casing and washed hole. Ran 5-1/2" tension packer on 2-3/8" tubing coated internally with plastic. Loaded annulus with water and Nocor 439 mixed at rate of 1 gallon chemical to 5 barrels water and set packer at 1,574'. Well accepting 253 barrels water per day at 0 psi.
