Pull rods and tubing, clean out to TD of 1722' and wash hole with 250 gallons of acid. Set tension packer at approximately 1650' on 2-3/8" O.D. tubing coated internally with plastic. Start fresh water injection down tubing at rate of about 200 BPD. Work will commence on or about 11-17-68.
