Propose to temporarily abandon Canyon perfs 7944-45' w/RBP, perforate Wolfcamp lime at 6250-56, 6271-76 and 6316-20 (1 SPF), treat w/2000 gals 15% NEFE acid plus ball sealers. Swab back load and evaluate. If commercial, will retreat and commingle with Canyon perfs.
