The well was shot with 230 quarts nitro glycerin(Liquid) from 975' to 1035' using New Mexico Glycerin Company. Well was plugged back from 1050' to 1035'. The sand strata was increased from just a slight showing of oil to approximately 30 barrels per day and an increase of gas. Well flowing.
