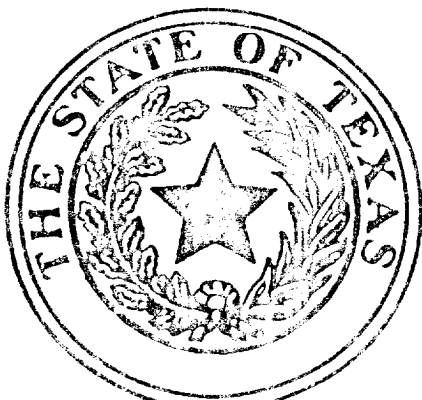

Article 1 is amended to read as follows:


"1. The name of the corporation is KIMBELL OIL COMPANY OF TEXAS."


ARTICLE THREE
