## DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

After plugging well back from Td 2337 to 435 we ran 435 feet of 7" OD #2 seamless new casing and cemented with 125 sacks of cement. We let stand 72 hours, bailed dry and gun-perforated with 250 shots from 395 to 425. Water shut-off OK.
