DETAILS OF WORK

We intend to complete this well in the Acoma (Slaughter) zone, San Andres formation at an approximate depth of 2,000'. We will run 8-5/8", 24#/ft., casing at 900' and 5 1/2", 14#/ft. casing at 1,900'. Both strings of pipe will be cemented with enough cement to protect the fresh water. The Slaughter zone will be sand frac'd at approximately 1,600' to 1,700'.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

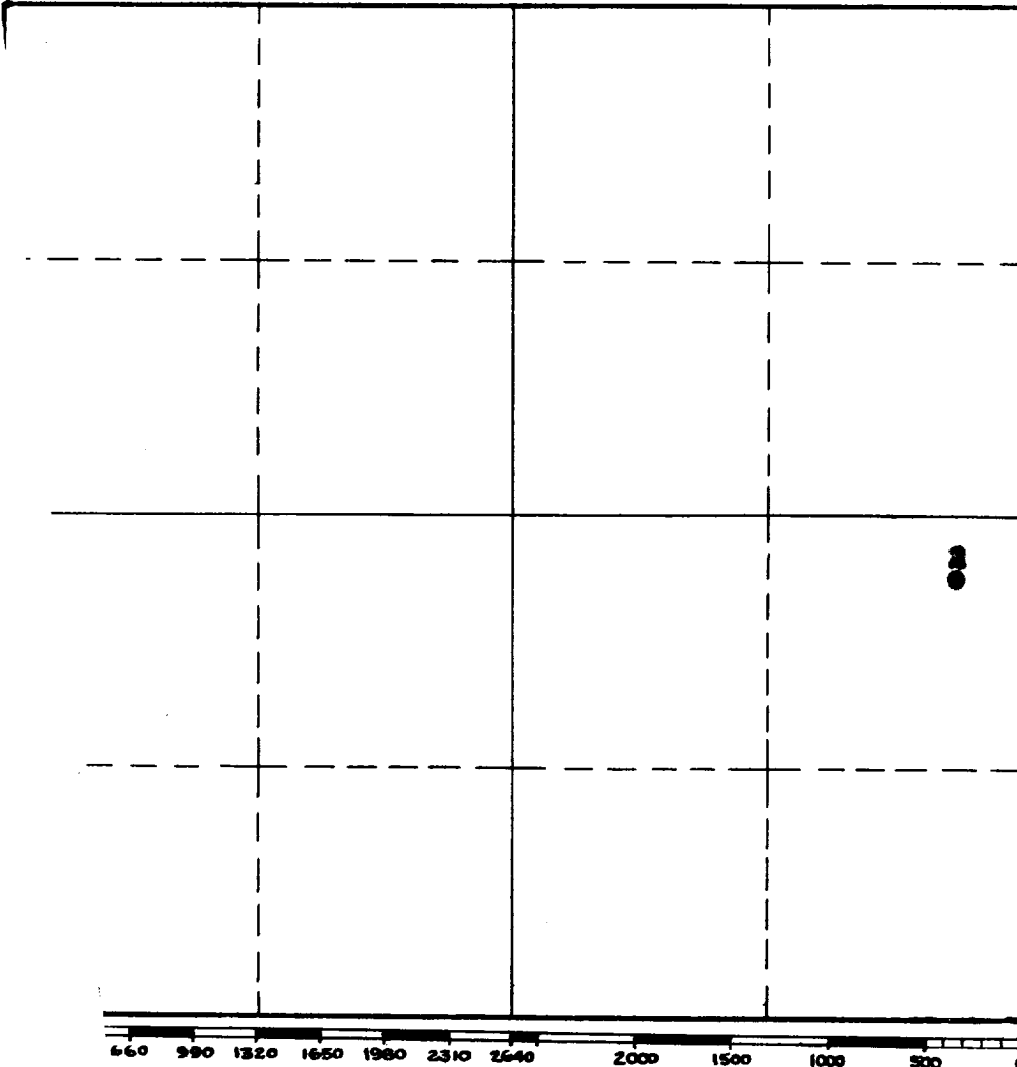
