Set 5775.65' of 4 1/2" J-55, 9.5# csg (180 Jts) @ 5789'. Cemented w/350 sx regular 4" gel cm. POB 4:00 PM 3-12-60. Ran logs. Tested 4 1/2" csg w/1250# for 30 minutes. No drop in pressure. Top of cement outside casing @ 3910'; located by Cemcton. At present the nearest Red Lake Grayburg Pool production is approximately one-half mile northwest of the subject well. In the event that any additional Red Lake Grayburg Pool wells are subsequently drilled nearer the proximity of the subject well, Humble Oil & Refining Company plans to contact the USGS District Office in Artesia, New Mexico, and discuss the need, if any, of circulating cement on the oil string casing in the subject well.
