Genlemen:

On September 16, 1959, a survey was made to locate your U. S. A., Malco Refineries "K" No. 2 well to a point 654.74 feet from the south line, and 1973.21 feet from the east line of Section 9, Township 18 South, Range 27 East, New Mexico Principal Meridian, Eddy County, New Mexico.

A flag was placed on the south quarter corner of Section 9, and the transit was placed over the point common to Section 9, 10, 15, and 16 of the above mentioned Township and Range. We then chained South 89 Deg. 59 Min. West, a distance of 1973.21 feet to a point marked by a 2 inch by 2 inch wood hub with a tack; thence North 0 Deg. 23 Min. East, a distance of 654.74 feet to the location marked by a $\frac{1}{4}$ inch steel pin. To Check we then chained back to our wood hub, a distance of 654.74 feet; thence South 89 Deg. 59 Min. West, a distance of 653.72 feet to the above mentioned quarter corner for a closure error of less than 0.30 feet.

I hereby certify that the foregoing survey was made in the field under my supervision and that the same is true and correct to the best of my knowledge and belief.
