On July 30, 1959, a survey was made to locate your No. 9 Well on the USA Malco Refineries "C" lease at a point 1980 feet from the South line and 660 feet from the West line of Section 10, Township 18 South, Range 27 East, N.E.P.M., Eddy County, New Mexico.

A flag was set at the USGLO Quarter corner marker common to Sections 9 and 10 and the Transit was set up at the USGLO Section corner marker common to Sections 9, 10, 15 and 16.
