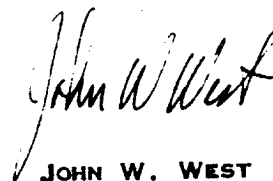
ON AUGUST 27, 1960, A SURVEY WAS MADE TO LOCATE YOUR USA MALCO REFINERIES "G" NO. 12 AT A POINT 986.04 FEET FROM THE SOUTH LINE AND 330.0 FEET FROM THE WEST LINE OF SECTION 10, TOWNSHIP 18 SOUTH, RANGE 27 EAST, N.M.P.M., EDDY COUNTY, NEW MEXICO.

A FLAG WAS SET UP AT THE USGLO MARKER SET FOR THE WEST QUARTER SECTION CORNER OF SAID SECTION 10. THE TRANSIT WAS SET UP AT THE USGLO MARKER SET FOR THE SOUTHWEST CORNER OF SAID SECTION 10. THENCE CHAINING FROM THE TRANSIT N 0°23'E ALONG THE WEST LINE OF SAID SECTION 10 A DISTANCE OF 986.04 FEET SETTING A HUB WITH TACK AT THIS POINT. THEN THE TRANSIT WAS SET UP AT SAID HUB AND A FORE SIGHT WAS TAKEN ON THE ABOVE MENTIONED FLAG. THENCE CHAINING FROM THE TRANSIT S 89°13'E A DISTANCE OF 330.0 FEET TO THE LOCATION OF YOUR USA MALCO REFINERIES "G" NO. 12.

AS A CHECK ON YOUR SURVEY WE CHAINED N 89°13'W A DISTANCE OF 330.0 FEET AND N 0°23'E A DISTANCE OF 1646.24 FEET TO THE USGLO MARKER SET FOR THE WEST QUARTER SECTION CORNER OF SAID SECTION 10, CLOSING WITHIN 0.20 FEET OF THE DISTANCE SHOWN ON THE USGLO TOWNSHIP PLATS.
