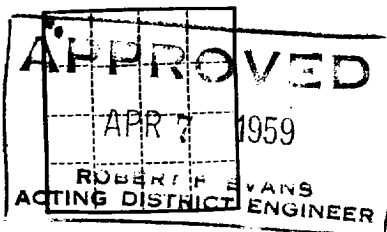

DETAILS OF WORK

(State names of and expected depths to objective sands; show sizes, weights, and lengths of proposed casings; indicate mudding jobs, cementing points, and all other important proposed work)

It is proposed to drill to a depth of 6200' to the Abo formation. Casing and cementing program is proposed as follows:

8-5/8" OD, 24#, J-55 Casing set at approximately 1050' with 900 sacks of cement.

5-1/2" OD, 14 and 15.8#, J-55 Casing set at approximately 6200' with 200 sacks of cement.

This well is to be known as Aztec Oil & Gas Company, et al, Federal EA #1.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
