Spud 11" hole 4-4-60. On 4-8-60 8 5/8" OD 24# J-55 ST&C casing was run and set at 1487' with sufficient cement to circulate. After WOC 24 hours tested casing with 1000# PSI for 30 minutes with no loss in pressure. Reduced hole to 7 7/8" at 1487' and resumed drilling operations.
