**I plan to drill a 1700' Grayburg Sand test, using both rotary and cable tools.**  
**I propose to set approximately 120' of 3 3/8" surface casing with 23 sacks.**  
**I plan to drill to 1600', and there run a string of 3 1/2" casing**  
**We will core ahead below this. If production is indicated, we will bridge just below this pipe, pick it up and cement with sufficient cement to circulate to the surface, making an open hole completion.**  
**All casing will be run and cemented using methods approved by the United States Geological Survey.**

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
