THE ABOVE WELL WAS DRILLED TO A T. D. OF 2100 FEET AND PLUGGED. HOLE FILLED WITH GRAVEL TO 2075 FEET AND RAN CEMENT PLUG OF 5 SACKS. FILLED WITH GRAVEL TO 1875 FEET AND SET 10 SACKS CEMENT PLUG. FILLED HOLE WITH MUD TO 400 FEET AND RAN 5 SACKS CEMENT PLUG. KNOCKED OFF 8 INCH CASING AT 250 FEET AND PULLED. DROVE WOODEN PLUG IN CASING AND CEMENTED WITH 8 SACKS OF CEMENT. FILLED WITH MUD TO SURFACE, RAN 8 SACKS CEMENT PLUG AT SURFACE AND SET REGULATION MARKER.
