## DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

The 7" O. D. new pipe was set in this hole at a depth of 1667' and cemented with 35 sacks of cement by Halliburton. After allowing to remain for 72 hours the hole was bailed dry and a test made for leaks. As no leaks appeared or developed, drilling was resumed.
