Circulated hole with mud laden fluid & set 35' cement on top of CIBP. Set 25 sx plug from 1700'-1600'. Cut 4-1/2" casing @ 1080'. Pulled & laid down 4-1/2" casing. Spotted 60 sx plug from 1130'-1030'. Tag plug @ 979'. Spotted 45 sx plug 584'-484'. Tagged plug too low. Set another 25 sx plug. Tagged plug top @ 472'. Set 10 sx surface plug and installed dry hole marker. Cut anchors and cleaned location. P&A complete. RD & MO unit.
