Then will set new A.P.I. 4 1/2" J-55 production csg. at T.D. and cement with approximately 175 sacks neat cement. Will run logs, perforate and sand-oil fracture for production. This well to be drilled with cable tools.

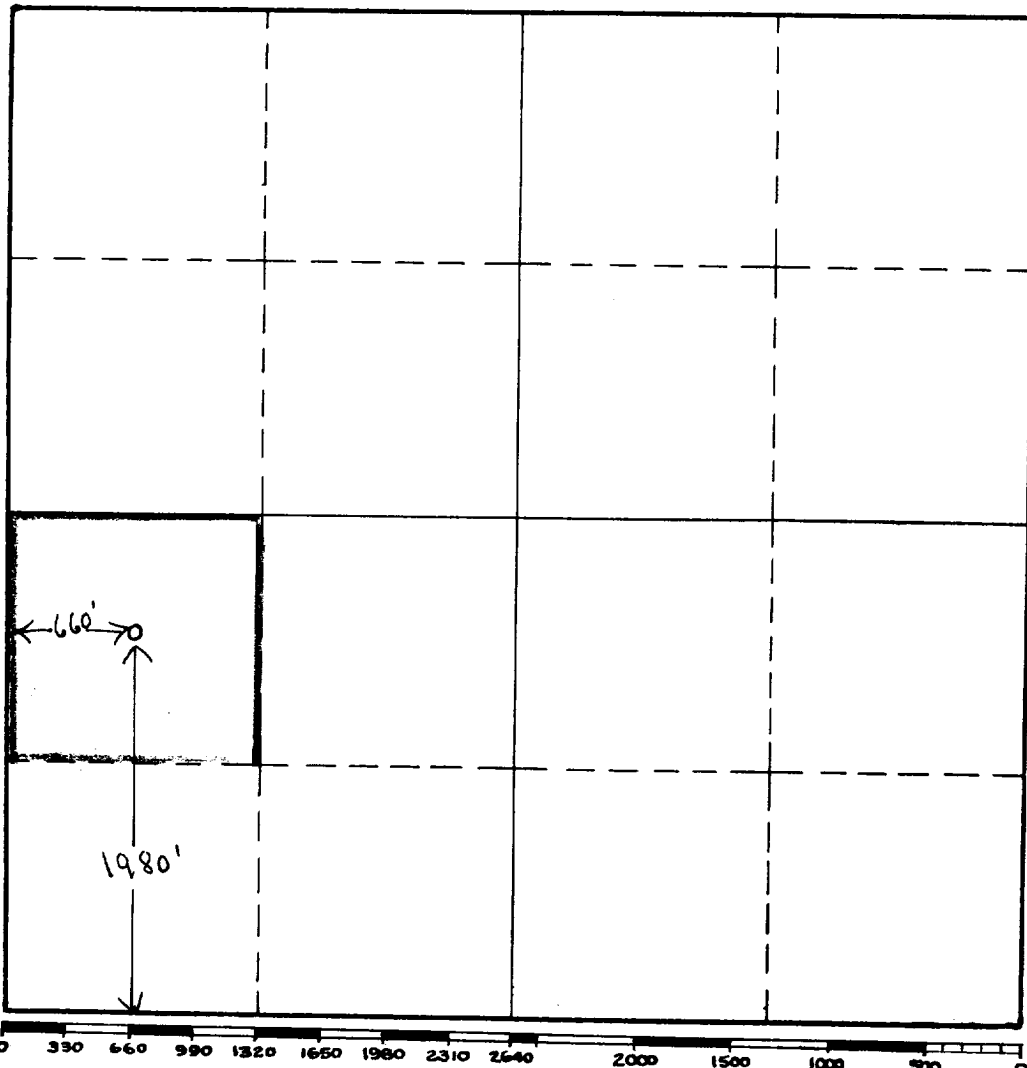
