Re-entered old well 1-9-64, could not re-enter nor mill 8 5/8" casing stub. Side tracked hole, drilled down alongside 8 5/8" casing from 355 ft. and back into old hole at 462 ft., maximum deviation in side tracked hole was 2° at 350 ft. On 1-31-64 cemented 8 5/8" surface casing with 100 ex. cement w/2% CaCl₂ and floccs, lost circulation additive. Cleaned out to 2690 ft.

On 2-15-64, ran 2709.16 ft. (84 jts.) of 4 1/2" OD 11.60 lb. J55-8R-STC casing set at 2690 ft. with 175 ex. Incor-Pozmix, 2% gel, 0.75% CFR-2, and 8 lb. salt/sk by Halliburton Company. Ran 500 gal. acid to clean up well bore before cementing. PD 8:35 P.M. 2-15-64.

Now preparing to perforate and fracture treat Queen, and Grayburg producing zones.

Instructions
