DETAILS OF WORK

Propose to drill to approximately 2875 feet. Will complete well in Grayburg and Livingston Sand. Will set new 8 5/8" 24' surface cas. at approximately 550' and cement with 75 sacks most cement. Then will set new I.P.I. & 1/2" J-55 production cas. at T.D. and cement with approximately 175 sacks most cement. Will run logs, perforate and sand-oil fracture for production. This well to be drilled with cable tools.

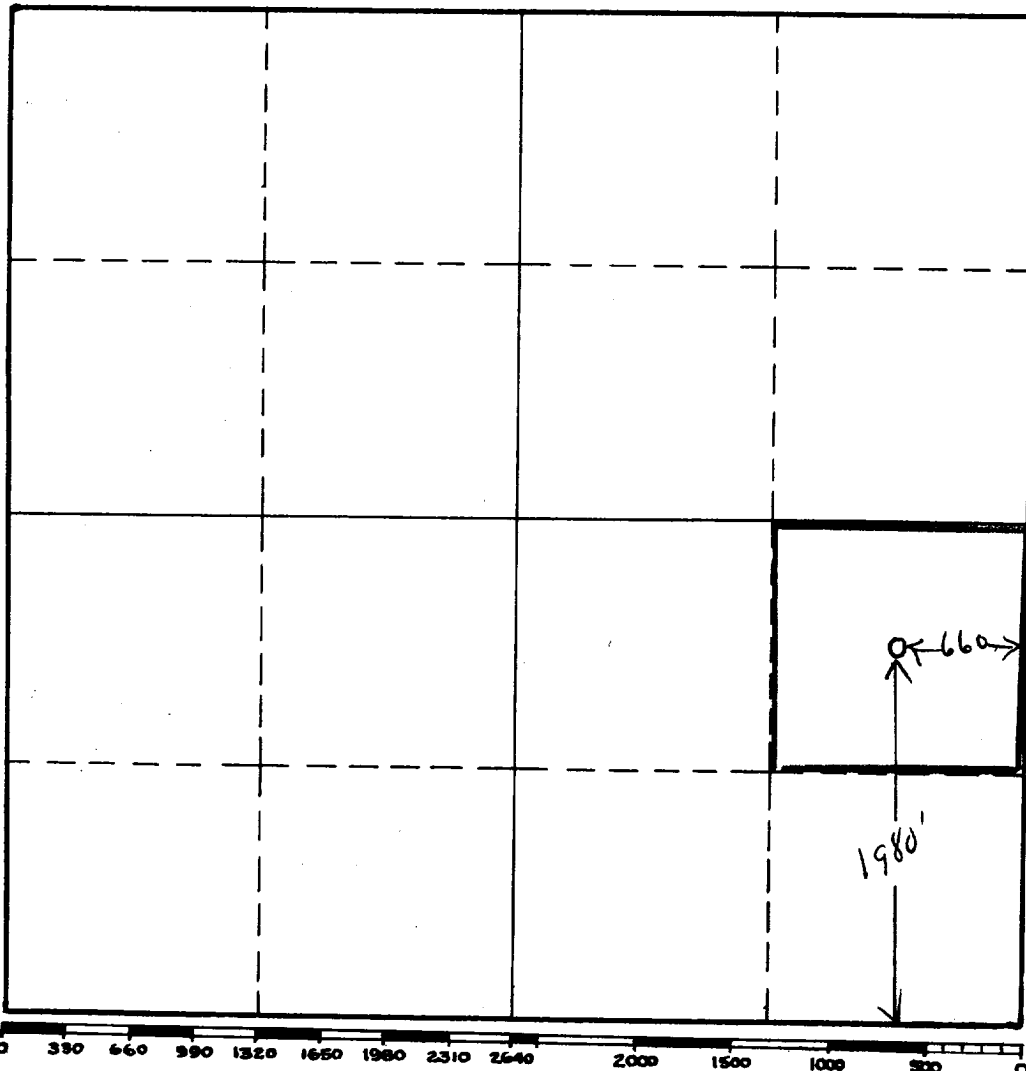
