DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Spudded in well 9-5-53. and drilled to 352' where we set 85/8" O.D. 28# new seamless casing and cemented same using 50 sacks mud and 50 sacks cement. Picked up hole full water at 318' could not bail down. After cement set 72 Hrs. drilled cement plug and bailed hole dry. We then took a 4 hr. bailing test showing a complete shut off. Top of salt 325'.
