DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On Oct. 16 th. we ran 2605' of 7" O.D. 22# casing and cemented with 100 sacks mud and 100 sacks cement. After the cement set 72 hrs. we drilled plug and cleaned to bottom at 2630' We then took a 24 hrs. bailing test recovering 1 1/2 bbls. oil and no water.

On Oct. 27 th. we treated the pay sand from 2606' to 2627' with 3000 gal. hydrafrac. After recovering the load oil the well made 30 bbls. oil with a very light trace of water.
