DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On June 3 1955 ran 2285' of 7" O.D. 26# seamless casing and cemented with 100 sacks. After cement set 72 hrs. drilled plug and cleaned out to bottom. We then took a 4 hr. bailing test which showed a complete water shut off. The well was then treated by Dowell with 10,000 gal. Colorado city oil and 15,000# sand. The break down pres. 2600# and the treating pres. 1400#. After the load oil was returned the well made 35 bbls. 1 hr. no water.
