Drilled well to 345'. Found no water. Ran 8 5/8". Did not cement. Drilled to 2572', reducing hole from 8 1/2" to 6 1/2" @ 2450'. Ran 2450' of 7" casing and cemented w/100 sex. Sand oiled w/10,000 gallons Fumrise oil and 20,000 lbs. sand. Before treatment, well bailed 13 gallons hourly. After treatment, well flowed 100 BOPD.
