DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Pulled 6-5/8 casing up to 1450 feet from top and filled hole with mud laden fluid to 1550 ft. and put in 5 ft. of rock and set 5 sacks of cement with dump bottom bailer pulled the rest of the 6-5/8 casing filled hole to 500 feet with mud laden fluid and put in 5 feet of rock and set 3 sacks of cement pulled the 10 1/2 casing and filled the hole to the top with mud laden fluid and set a piece of pipe extending 4 feet above the ground as a permanent marker
