Pumped 25 sacks regular cement, followed by rubber plug down 4½ casing to 1900', let set 48 hours, tested plug to 2500# PSI held ok. Filled hole with mud. Cut 4½ casing off @ 986', pulled casing to 608' (bottom of surface pipe) spotted 15 sack plug, finished pulling 4½ casing out of hole.

Left in well 1249'-4½ and 608'-7" surface pipe.
Ran 10 sack plug @ surface - set marker.
