DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

During the month of June, 1948 an effort was made to clean out and deepen this old temporarily abandoned well. Due to junk in hole we did not succeed in cleaning it up. Therefore we set 10 sack cement plug at about 1900' which is above Artesia Field Sand pay and filled hole with mud. Set marker over hole.

Old records show T. D. 2090' with 10" @ 244', 8 5/8" @ 641' and 7" @ 1881', however 7" casing pulled years ago, also the 10" was pulled long ago. During the final abandonment all 8 5/8" casing was pulled and a 10 sack cement plug was set at approximately 655'.
