FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

1. Pump 15-sack cement plug to bottom of hole using 10# mud with which to pump plug. Fill up 110 feet.
2. Pressure test plug.
3. Cut off and pull recoverable casing.
4. Fill hole with 10# mud.
5. Spot 15-sack cement plug at bottom of surface casing. Fill up 40 feet.
6. Put 5-sack cement plug and pipe marker in top of surface pipe. Fill up 20 feet.
