DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Had 40' of fresh water in hole from 235-250, which did not lower with bailer. Had some salt water in hole at 460'. Ran 8 5/8" to 515 and cemented with 50 sack on 10-24-54. Used this amount of cement so it would cover both water zones. On October 26, 1954, drilled out plug and tested- had water shut off.
