Moved on company tools, attempted to cleanout. Moved on cable tools, set 8 5/8" surface pipe into old surface pipe at 254', cleaned out to 2051', deepened to 2310'. Set & mudded 7" casing at 2310', moved off cable tools and moved on company rotary, deepened to 2751'. Pulled 7" casing, ran 4 1/2" OD 11.6 lb. casing, set at 2751' w/325 sx cement. Perforated 1 jet shot each at 1727', 1729', 1939', 1941', 1943', 2687', 2711', 2714', 2717'. Fractured w/750 gal. acid, 84000 lbs. sand, and 1268 bbls. water. Swab water. Plug back w/sand, perforate 4 holes 1933'-1935', squeeze w/150 sx, drill out & perforate 2 holes at 1989', set bride plug at 1980', attempt to squeeze but could not. Frac w/250 gal. acid, 21,250 lbs. sand, 16,000 gal. water. Produce water. Shut-in.
