Detailed account of work done, nature and quantity of materials used, and results obtained.

Ran 2-3/8 tubing with packer to 1850', set packer, spotted 25 sack plug at bottom of hole, let set 48 hours, tested plug, held ok. Pulled tubing and packer out of hole. Cut 4½ casing off @ 1490', pulled same out of hole. Pulled 990' of 7" to bottom of surface pipe, spotted 15 sack plug @ bottom of surface pipe, finished pulling 7" out of hole, set 10 sack plug and marker @ surface in top of 8-5/8 surface pipe. All 8-5/8 surface pipe left in well, hole was loaded with mud.
