Pumped 25 sack plug down $4\frac{1}{2}$ casing, followed with rubber plug and mud, let set 48 hours, tested plug, held ok. Cut $4\frac{1}{2}$ casing off @ 1383', pulled same to bottom of surface pipe, spotted 15 sack plug, finished pulling $4\frac{1}{2}$ casing out of well. Cut 8-5/8 surface pipe off @ 184 ft., pulled out of hole, put 10 sack plug and marker @ surface.
